# **RAISE THE ROOF EVENT**

On July 7th, Board President Cynthia Hull opened her beautiful home and garden to 120 attendees at our first "Raise the Roof" fundraising gala. She wowed the crowd with her introduction of nationally recognized affordable housing architect and professor Sam Davis who used a gameshow-style delivery to educate attendees on affordable design fundamentals. The total raised from the night was \$990,000 (including the matching funds).









How do you feel the housing challenge impacts the county employees? Instability

affects the families we serve, in addition to our employees. Having stable housing helps with the ability to move them forward. The students are also impacted greatly when there is instability at home.

How will the partnership with ARCH impact the community? *It already has made an impact. It has been a morale lifter for the* staff. They know that we are working toward solutions with ARCH.

### **SUNBEAM**

Having closed out our first matching grant, design work on eight homes in Sunbeam has begun. County ARPA funds provided the final financing which will ensure that the homes are affordable to those earning up to 140% of area median income.

# A MATCHING CHALLENGE GRANT FOR THE BCSD

The \$990,000 raised will be used in the first phase of a new ARCH-Blaine County School District development partnership.

ARCH will break ground on six to eight units of housing for school staff in the Spring of 2023 and will partner with WRHS Residential Construction Academy students on those school districtcontrolled housing for school staff.

Housing angel Jeanne Herberger accelerated the fundraising for Blaine County School District housing by announcing her second million-dollar challenge at our fundraiser.

## THE PIPELINE TIMELINE:

ARCH is constantly working towards bridging the housing affordability gap. At any given time, ARCH has developments in every stage of the pipeline timeline.





#### IDENTIFYING AND PURCHASING LAND Step One: 1 month to several years

The development process begins with identifying and purchasing land.

LAND IS ENTITLED Step Two: 3-6 months

The land is entitled, which means it goes through the City approval process.



#### DESIGN HOUSING PROCESS Step Three: 3-4 months

Once entitled, ARCH designs the housing process. This includes architecture and engineering.

### BUILDING PERMIT SUBMITTED Step Four: 2-4 weeks

ARCH submits for a building permit.



### CONSTRUCTION

#### Step Five: about 12 months

Construction follows once a permit is acquired.



#### TENANTS / OWNERS MOVE IN Step Six: immediately (Families move in as contractors exit) Anywhere from two to five years after

initial purchase of land, the entire process will be finished.

# FUNDING

Continued community support has had a significant impact on this year's financial position. You have enabled ARCH to enter our second employer partnership. Thanks to you, we are helping the Blaine County School District to attract and retain employees. We continue to utilize federal housing dollars in order to serve our community; however, the greater emphasis on philanthropic support reflected in these financials enables us to deliver housing to a wider segment of the valley.
